Mayor Sefrit reported that interest rates were very comparable for the proposed Main Street resurfacing. Superintendent Hargis will be contacting Black Top Services to put the City on the schedule for Spring 2017.

Clerk Tracy will be getting more information regarding renewing the City's SAM registration that is due March 1, 2017.

City received 3 complaints regarding dogs running loose. City Attorney Varley will start process to notify owners of the complaints.




