MINUTES OF THE REGULAR CITY COUNCIL MEETING

Thursday, June 15, 2023

The meeting was called to order by Mayor Frank Sefrit at 7:00 pm.

Members present included Larry McAlpin, Mattea Fritz, and Bob Riddle. Chris Stewart and Mike DeVoe were absent.

Mayor Frank Sefrit, City Superintendent Ben Fritz, and City Clerk Megan Wright were also present.

It was moved by Bob Riddle and seconded by Mattea Fritz to approve the consent agenda items which included the Agenda, Minutes from the May City Council Meeting Budget Amendment, and Additional Water Loan Public Hearings, Claims for the City, Museum, Fire Department, and Mighty Wash, Financial Reports (Treasurer's Spreadsheet, Income and Expense, Balance Sheet), and Reconciliations (General Checking, Fire Dept, Petty Cash, Utility). All members voted in favor, motion carried.

It was moved by Larry McAlpin and seconded by Bob Riddle to approve Resolution 2023-23 Town & Country tobacco permit. All members voted in favor, motion carried.

It was moved by Bob Riddle and seconded by Larry McAlpin to approve closing Main St. from the Library to 5th St. for the street dance on July 1st. All members voted in favor, motion carried.

It was moved by Mattea Fritz and seconded by Bob Riddle to approve a fence permit for E. Herzberg. All members voted in favor, motion carried.

It was moved by Mattea Fritz and seconded by Bob Riddle to approve installing a 1 door key card system at the Community Center. All members voted in favor, motion carried.


It was moved by Bob Riddle and seconded by Larry McAlpin to approve implementation of a cleaning list for renters and cleaners at the Miner Pavilion. All members voted in favor, motion carried.

It was moved by Mattea Fritz and seconded by Bob Riddle to approve 5-year loan from Bank Iowa. All members voted in favor, motion carried.


Larry McAlpin made a motion to adjourn the meeting and it was seconded by Bob Riddle. All members voted in favor so the motion carried.
